PROVIDES TRANSITIONAL HOUSING TO WOMEN AND THEIR CHILDREN FROM THROUGHOUT THE DALLAS-FORT WORTH METROPLEX WHO ARE VICTIMS OF DOMESTIC VIOLENCE. DURING 2019, THE FOUNDATION PROVIDED TRANSITIONAL HOUSING TO 81 CLIENTS STAYING IN 18 APARTMENTS LEASED BY THE FOUNDATION AND PROVIDED RENT-FREE TO THE CLIENTS WHO MAY RESIDE IN THE HOUSING FOR 3 TO 24 MONTHS. ADDITIONALLY, THE ORGANIZATION IMPLEMENTS A RAPID REHOUSING PROGRAM IN WHICH TMWF PROVIDES SHORT TERM RENTAL ASSISTANCE AND SERVICES FOR 14 CLIENTS TO HELP THEM FIND PERMANENT HOUSING AND INCREASE THEIR SELF-SUFFICIENCY.
